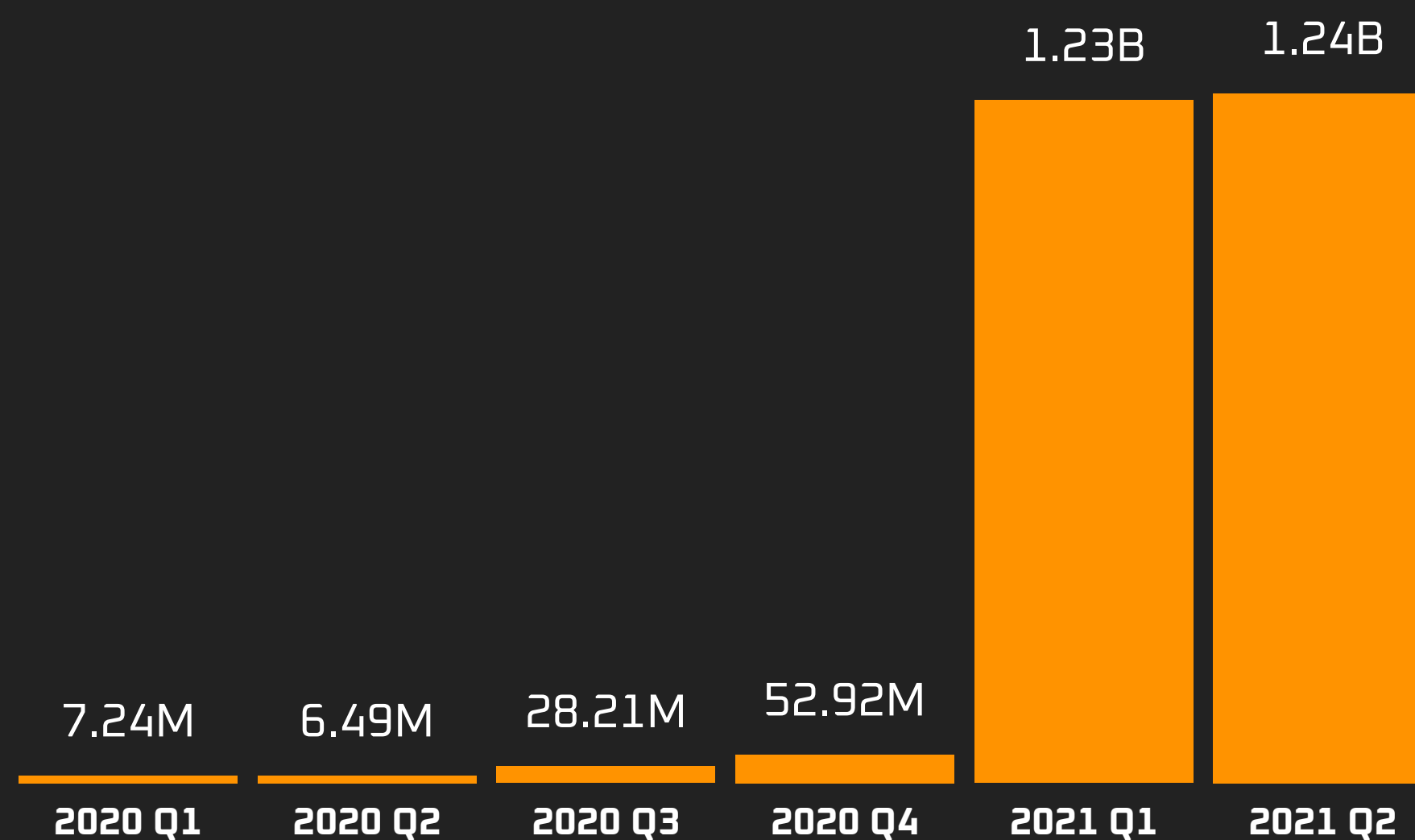

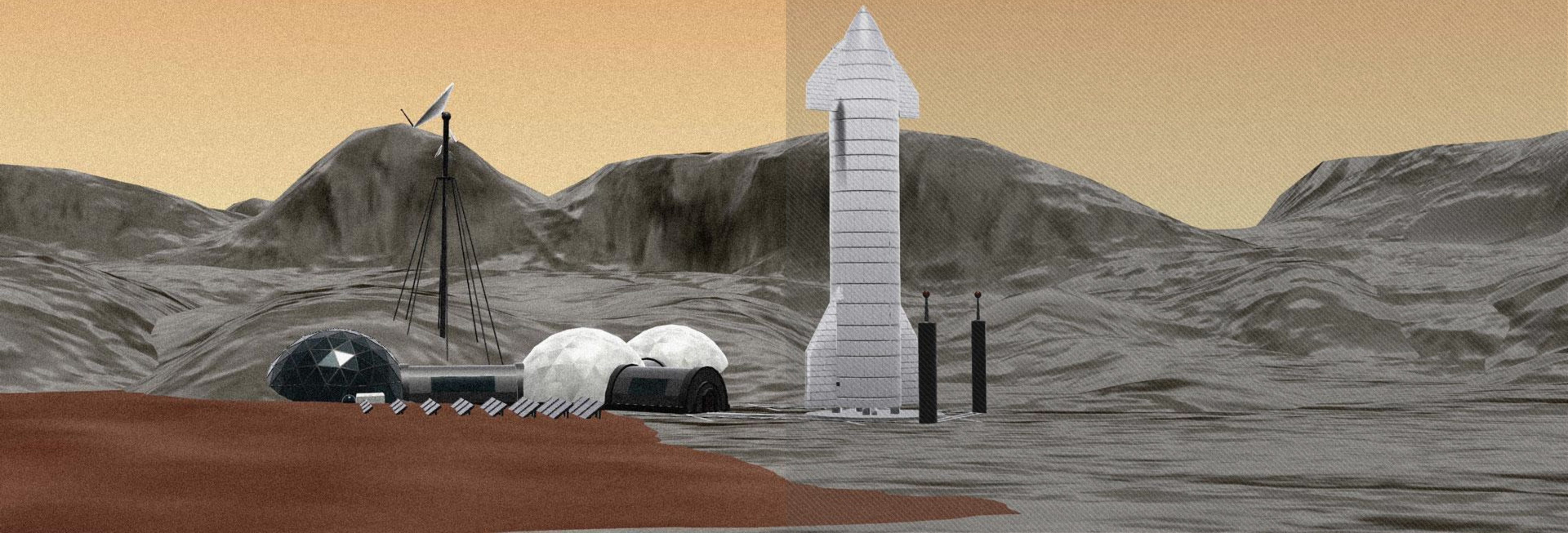
- **NFT is gaining momentum and growth is accelerating**

- Leverage Gamification and Token Yield farming to **create attractive yields & tokenomics for DeFi traders and investors.**

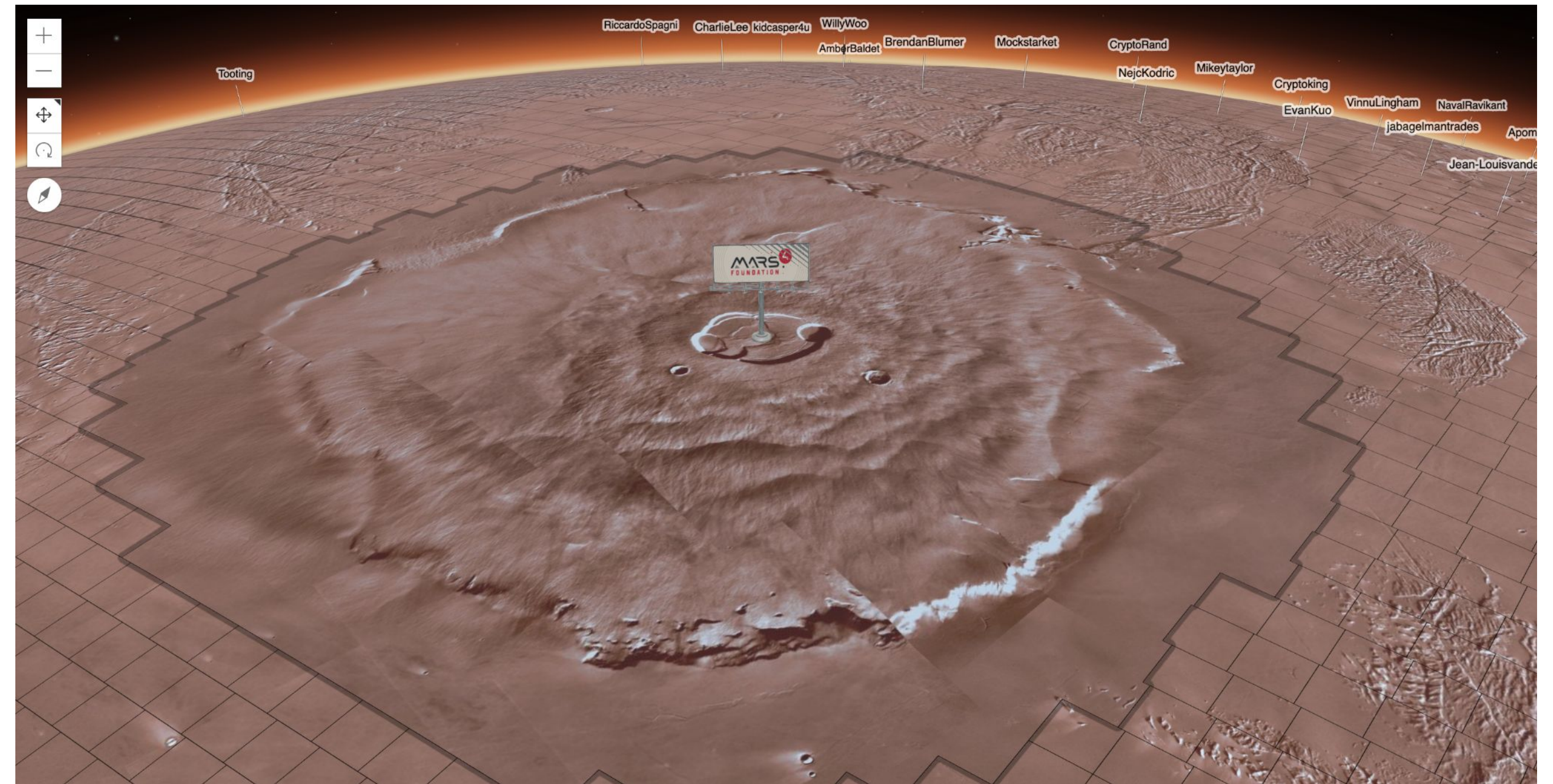
- **Enable humanity to explore Mars** virtually by creating the Mars4.me VR platform, adventures, fun and excitement.





## MARS4 PROJECT ESSENCE

- Interactive **3D Virtual World** with the Red planet divided into **land plots**, each **represented** by a **unique NFT**.
- Dual tokenomics of a **Fixed** supply **MARS\$ tokens 4B** for gaming, trading and NFT minting & **Fixed supply of Mars NFTs** (**99.888 NFTs** representing Mars surface).
- **Liquidity mining** - tokens are redistributed to the NFT holders.

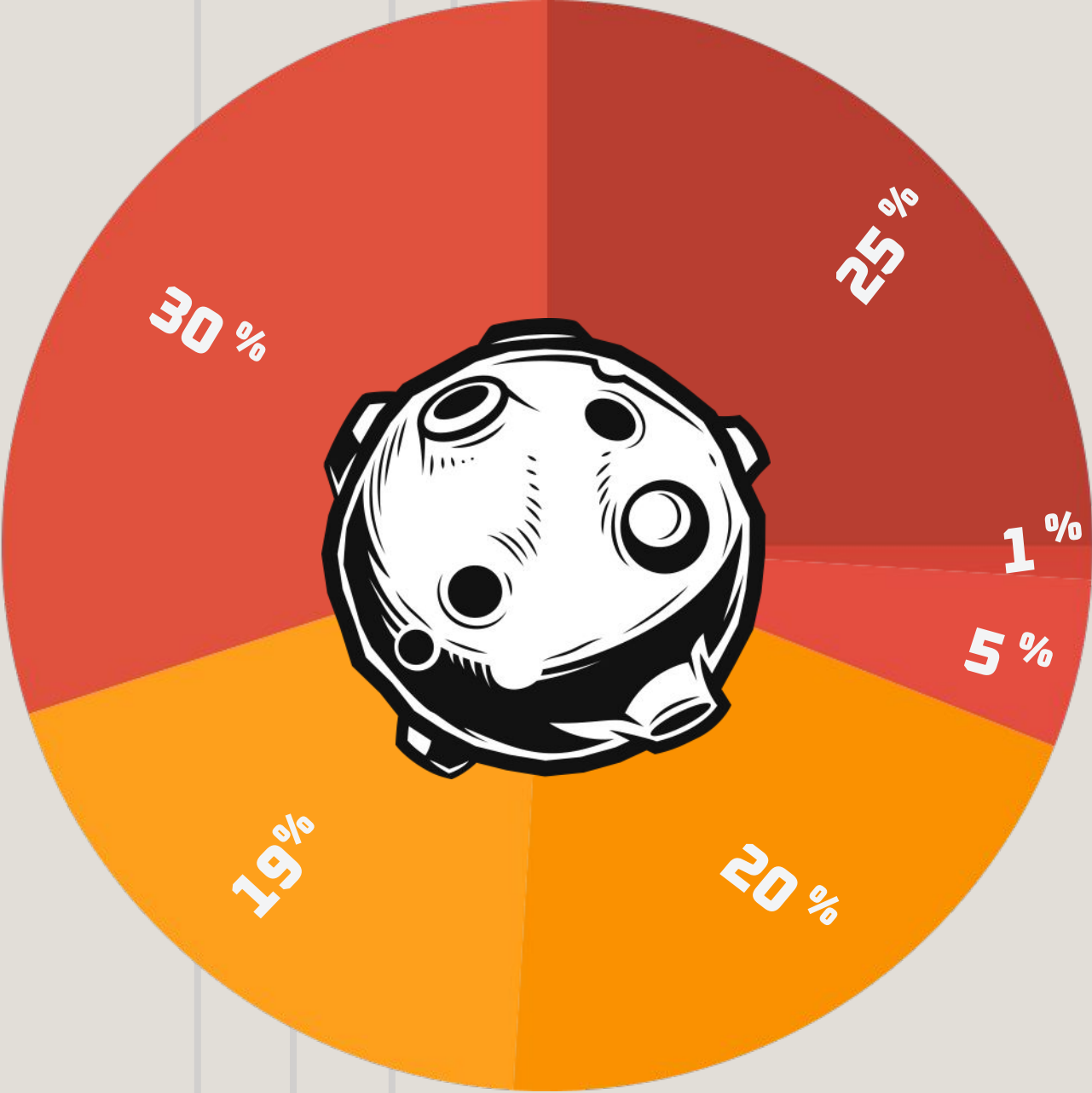
